

In 2015, inadequate instrument processing was number 8 on the ECRI Institute's list of top 10 technology hazards in health care, and accreditation surveyors are looking to see if processing practices are congruent with current evidence-based guidelines, position papers and instructions for use. Immediate use steam sterilization, terminal sterilization and short cycles have caused some confusion for personnel responsible for processing ophthalmic instruments. Explore these issues and examples of best practices. Review recommendations and guidelines from the Association of periOperative Registered Nurses, the Association for the Advancement of

Medical Instrumentation and the American Society of Cataract and Refractive Surgery.

Medicare and/or deemed status accreditation agency surveys and survey deficient practice statements can be confusing and frustrating. Responding with a Plan of Correction (POC), then implementing this plan through directed tasks and policies, can be daunting, even for experienced ASC professionals. The letter accompanying the Statement of Deficiencies, which threatens to close your ASC if you do not submit an acceptable POC within 10 days, can add to the stress of this review.-Bring your recent survey findings, concerns and toughest questions to this session where we will discuss how your ASC can respond effectively to specific survey situations and related Medicare communications in the future.
